PILOT PROFICIENCY BADGES

BLUE BADGE & CERTIFICATE Minimum Licence = PPL, RPL or AMC



RED BADGE & CERTIFICATE

Minimum Licence = PPL, RPL or AMC Minimum Hours = 80 Any three options (total 3)



BRONZE BADGE & CERTIFICATE

Minimum Licence = PPL, RPL or AMC Minimum Hours = 110 Any two additional options (total 5)



SILVER BADGE & CERTIFICATE

Minimum Licence = PPL, RPL or AMC Minimum Hours = 200 Any three additional options (total 8)



GOLD BADGE & CERTIFICATE

Minimum Licence = PPL, RPL or AMC Minimum Hours = 350 Total 200 PinC Any four additional options (total 12)



The Flying NZ Pilot Proficiency Scheme promotes air safety and encourages general aviation pilots to continue with valuable proficiency training. providing the opportunity to attain in sequence the Pilot Proficiency Badges and Certificates. Flying NZ is committed to continue to develop and support flying as a sport and recreational activity, encouraging personal achievement, fun and participation in a safe environment.

THE PURPOSE

- ➤ To recognise and record defined levels of pilot experience and achievement.
- To encourage the self improvement of pilot skills
- To recognise improvement of skills with the participation of the Aero Club Pilot in other Flying NZ activities- Flying NZ Competitions, Wings International Competitions, the Flying NZ Air Safari and establishing World Records in association with FAI Federation of Aeronautique International.

ELIGIBILITY

- Hold a current Private Pilot Licence PPL, Recreational Pilot Licence RPL or an Advanced Microlight Pilot Certificate AMC.
- ▶ All Pilots on application for the Pilot Proficiency Award must be a current financial member of a Flying NZ affiliated Aero Club.

THE REWARDS

- ★ The requirements listed for each Pilot Proficiency Award are the minimum in each case.
- Applications for the highest level of achievement can be irrespective of whether the qualifications achieved by the applicant are current at the time of application.
- ★ The Blue Badge and Certificate recognises the achievement of receiving the Private Pilot Licence, Recreational Pilot Licence or an Advanced Microlight Pilot Certificate. This Blue award is issued free of charge when the application is received from the Aero Club.
- All other badges including the certificate are \$25.

PILOT PROFICIENCY OPTIONS

1 Cross Country

- 1.1 20 hours cross country. PinC including a flight greater than 100 nm in a straight line from the aerodrome of departure and incorporating a landing at two other aerodromes.
- 1.2 40 hours cross country PinC including a flight greater than 300nm and incorporating a landing at three other aerodromes.
- 1.3 Landing at 10 different aerodromes.
- 1.4 Flight into two international airports.

2 Instruments

- 2.1 Demonstrate competency to the satisfaction of an instrument rated instructor in the use of a GPS either fixed or a portable unit.
- 3 Night
- 3.1 Two take-offs and landings PinC.
- 4 Multi Engine Aircraft
- 4.1 50 hours PinC.
